Boys Haven contracts with a Psychiatrist to oversee the psychiatric needs of all of its clients. Boys Haven contracts with two RNs, an ARNP and a psychiatrist for in house medical needs. We contract with Home of the Innocents for ongoing medical health needs with their pediatrician. Residents over 18 are seen at U of L health clinics in the community. We also offer an on-campus medical clinic staffed by a volunteer doctor.
