The agency contracts with a psychiatrist and ARNP for evaluation and medication management weekly and as needed. Boys Haven has a contract for medical care with the Home of the Innocence M.D. for routine medical evaluation and treatment. We employ two part time RNs and have contracts with a RNP and an MD psychiatrist. In addition, we offer an on-campus medical clinic that is staffed by a volunteer doctor.
